## PREFACE

The Rules of the Ventura County Air Pollution Control District are contained within twelve Regulations. The following is a description of each:

Regulation I, GENERAL, includes definitions, abbreviations, and information regarding the Air Pollution Control Advisory Committee.

Regulation II, PERMITS, includes rules on permit requirements, applications, exemptions, denial, suspension, revocation; and rules on appeals, record keeping and reporting; plus appendices showing information required in applications and tables defining Best Available Control Technology (BACT) by process and pollutant.

Regulation III, FEES, includes Hearing Board Fees, Permit Fees and charges for technical reports, etc.

Regulation IV, PROHIBITIONS, includes rules on maximum allowable emissions, design criteria, new source performance standards, and national emission standards for hazardous pollutants, etc.

Regulation V, ORCHARD HEATERS, describes the types of complying heaters, and compliance requirements, etc.

Regulation VI, SOURCE TESTING AND STACK MONITORING, includes analytical methods, sampling and testing facilities, source tests, stack monitoring, etc.

Regulation VII, HEARING BOARD, discusses petitions, appeals, abatement orders, answers, notices, decisions, burden of proof, etc.

Regulation VIII, EMERGENCY ACTIONS, includes air monitoring, episode criteria, notifications, actions, etc.

Regulation IX, PUBLIC RECORDS, includes inspection of records, disclosure policy, trade secrets, etc.

Regulation X, TRANSPORTATION OUTREACH PROGRAM

Regulation XI, CONFORMITY

Regulation XII, ENFORCEMENT
