# REPLACEMENT OF TIER 1 & TIER 2, DIESEL AG ENGINES: CHECK BEFORE YOU BUY! NOT ALL TIER 4 ENGINES MEET THE NEW EMISSION LIMITS

# If you own or operate a Tier 1 or Tier 2 diesel Ag engine, the following information is important to you!

On August 1, 2013, the Ventura County Air Pollution Control District released an advisory informing owners and operators of agricultural (Ag) engines 50 BHP and greater of the upcoming California Air Resources Board's *Air Toxic Control Measure for Stationary Compression Ignition Engines* (ATCM) requirement to replace Tier 1 and Tier 2 Ag engines, beginning December 31, 2014 for engines rated at 175 BHP and greater, and after December 31, 2015 for engines rated at 50 to 174 BHP.

# Check Before You Buy!

The previous advisory stated that Tier 1 and Tier 2 engines should be replaced with an Interim Tier 4 Engine or a Tier 4 engine. The purpose of <u>this</u> advisory is to inform owners and operators of Ag engines that not all Tier 4 engines will meet the upcoming Particulate Matter (PM) emission standard for Ag engines. Although most will comply, some earlier model Tier 4 and Interim Tier 4 engines may not meet the upcoming emission standards.

<u>Check before you buy</u>, to be sure that any Tier 4 engine you purchase meets the applicable emission standard for that engine BHP rating. Don't spend money on an engine that does not comply with the upcoming emission limits. Another option is to install an electric motor in place of a diesel engine.

The table below shows Ag engine emission standards and due dates, by BHP rating:

# Tier 1 and Tier 2 Engines

The ATCM prohibits the operation of Tier 1 and Tier 2 Ag engines after December 31, 2014 for engines rated at 175 BHP and greater, and after December 31, 2015 for engines rated at 50 to 174 BHP. The compliance dates for <u>some</u> Tier 2 engines may be extended (with APCD approval) to no more than 12 years after the date of initial installation of the engine. "Date of initial installation" for a diesel agricultural engine is defined in the ATCM as, "one year from January 1 of the engine model year". In other words, the following January. For example, for a 2006 model year engine, the District will assume the date of initial installation and compliance date.

#### Funding Available

The APCD will have a limited amount of funding available to qualified applicants to help purchase a new engine or electric motor in order to comply with the upcoming diesel Ag engine emission limits. #### **APCD Enforcement Program**

All diesel Ag engines, rated at 50 BHP or greater, must be registered with the APCD, <u>including new replacement engines</u>. Electric motors do not require registration. Be advised that the APCD will take enforcement action against owners of unregistered Ag engines and owners of Tier 1 and Tier 2 engines operated after their compliance date. Owners of unregistered Ag engines or, Tier 1, or Tier 2 Ag engines will be issued Notices of Violation and monetary penalties will be sought. The California Health and Safety Code allows penalties of up to \$1,000 per day for each day of violation.
