Governor Brown signs agreement with Mexico to reduce greenhouse gases

On July 28, Governor Edmund G. Brown Jr. and Mexican environment officials signed an agreement to help reduce greenhouse gas emissions and combat climate change. “California can’t do it alone and with this new partnership with Mexico we can make real progress on reducing dangerous greenhouse gases,” said Governor Brown.

The agreement was signed by Governor Brown, Mexico’s Ministry of Environment and Natural Resources Undersecretary Rodolfo Lacy and Mexican National Forestry Commission Director General Jorge Rescala Pérez.

“Mexico and California have a long and rich history of environmental cooperation, and recognize each other as strategic partners in coping with climate change challenges and protecting and preserving our natural resources. The agreement signed today will take our joint work to a whole new level of cooperation, which will reflect in tangible and

concrete results that will inure to our mutual benefit,” said Mexico’s Ministry of Environment and Natural Resources Undersecretary Rodolfo Lacy.

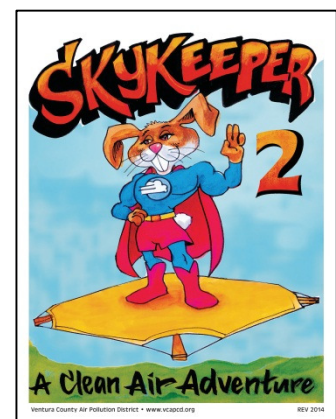
The pact seeks to enhance cooperation through a range of activities, including:

- Aligning greenhouse gas reduction programs and strategies;
- Collaborating on fire emergency response along the border and other climate change adaptation strategies;
- Improving air quality, including reducing pollution and expanding markets for clean energy technologies; and
- Strengthening fuel and truck efficiency standards and supporting green freight initiatives.

“In line with the priorities of the Mexican Government for the forestry sector, the Memorandum of Understanding signed today with the State of California lays down the conditions and excellent opportunities for

mutual cooperation to strengthen our capacity to prevent and respond to forest fires, a key issue in our common border,” said Mexican National Forestry Commission Director General Jorge Rescala Pérez.

The agreement with Mexico comes on the heels of similar agreements signed in 2013 with the governments of British Columbia and the states of Oregon and Washington and China’s National Development and Reform Commission – the first agreement of its kind on climate change between the commission and a

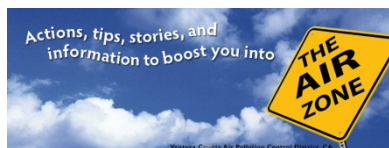
subnational entity. For the past several years, the California Air Resources Board and Quebec have worked together to fully harmonize their cap-and-trade programs.

Autism & the environment. In July, the **National Institute of Environmental Health Sciences** released a report on the link between environmental factors and autism. In terms of air pollution, the report makes the following statements:

- A 2011 study reported that children living within 1,014 feet, or a little less than 3.5 football fields, of a freeway, at birth, were twice as likely to develop autism.
- Building on those findings, in 2013, researchers reported an association between exposure to traffic-related air pollution, as well as components of regional air pollution, and an increased risk of autism.
- A 2014 study pointed to a likely gene-environment



interaction. Children whose genetic makeup cases them to be more susceptible to the health effects of high levels of air pollution showed the highest risk for autism. The National Institute of Environmental Health Sciences is part of the U.S. Department of Health and Human Services. Advisory Committee Actions

On August 26, 2014, the APCD Advisory Committee considered an update to the APCD Advisory Committee's Conflict of Interest Code.

The Political Reform Act of 1974 prohibits any public official, including any APCD Advisory Committee member, from participating in any decision-making process in which it is reasonably foreseeable that the decision will have a material financial effect, distinguishable from its effect on the public generally, on certain financial interests of the official. The Act also requires filing of financial disclosure statements. The APCD Advisory Committee's Conflict of Interest Code (Code) requires each Committee member to file a disclosure statement regarding economic interests by April 1 of each year.

Currently, the County of Ventura Clerk of the Board is updating the conflict of interest codes for all of the entities in Ventura County, including the APCD Advisory Committee. This means that the Conflict of Interest Code for the APCD Advisory Committee should be updated as well.

The APCD Advisory Committee approved staff's recommendation to adopt by reference a standard Conflict of Interest Code for the Committee. This standard code has been approved by the California Fair Political Practices Commission for this purpose. Adoption of such a standard Conflict of Interest Code will enable any future revisions to the state code to be automatically included in the APCD Advisory Committee's Code.

The Ventura County Air Pollution Control Board is scheduled to consider the updated APCD Advisory Committee Conflict of Interest Code at its September 9, 2014 meeting. If approved by the Air Pollution Control Board, the Code will be submitted to the Ventura County Board of Supervisors for final approval at a later date.
