



**NOTICE OF ADVISORY COMMITTEE MEETING  
PROPOSED AMENDMENTS TO RULE 71, CRUDE OIL AND REACTIVE  
ORGANIC COMPOUND LIQUIDS AND RULE 74.10,  
COMPONENTS AT CRUDE OIL AND NATURAL GAS PRODUCTION  
AND PROCESSING FACILITIES**

The Ventura County Air Pollution Control District (VCAPCD) will hold an Advisory Committee Meeting on November 30, 2023, to discuss proposed amendments to Rule 71 and Rule 74.10.

Staff is proposing amendments to Rule 71 to address revised or additional definitions in relation to proposed amendments to Rule 74.10 and the recent amendments to the California Air Resources Board's Greenhouse Gas Emission Standards for Crude Oil and Natural Gas Facilities (CARB GHG Oil and Gas Regulation).

Staff is also proposing amendments to Rule 74.10 to reduce Reactive Organic Compound (ROC) emissions from crude oil and natural gas production and processing equipment as proposed in the VCAPCD Best Available Retrofit Control Technology (BARCT) schedule approved on December 11, 2018.

As amended by Assembly Bill 617 (C. Garcia, Chapter 136, Statutes of 2017), Health and Safety Code section 40920.6(c) requires each local air district that is a nonattainment area for one or more air pollutants shall adopt an expedited schedule for the implementation of BARCT by the earliest feasible date, but in any event, not later than December 31, 2023. On December 11, 2018, the Ventura County Air Pollution Control Board approved a BARCT Rule Development Schedule. As part of this Rule Development Schedule, VCAPCD staff are proposing to implement BARCT by adopting revisions to Rule 74.10 to reduce emissions from crude oil and natural gas production and processing equipment.
